**EMERGENCY PROCEDURES** 24 HOUR ADVICE IN A TRANSPORT EMERGENCY ONLY: 0800 387 668

IF THIS HAPPENS	DO THIS
<b>Tanker/Vehicle Accident</b>	Switch off engine and electrical equipment. Keep people away, warn other traffic. Check for spills, leaks. <b>Call the emergency services: Dial 111</b>
<b>Spill or leak</b>	<b>DO NOT</b> touch or walk through spilled material. Wear PVC overalls, chemical resistant gloves, facemask or goggles. Stop leak when safe to do so. Prevent entry into waterways, drains, or confined areas. <b>Small Spill:</b> Pick up with sand or other non-combustible absorbent material and place into containers for later disposal. <b>Large Spill:</b> Dike far ahead of liquid spill for later disposal. Cover powder spill with plastic sheet or tarp to minimize spreading. Prevent entry into waterways, drains or confined areas. Wash down affected area with water plus detergent. Absorb and collect washings and place in the same sealable container for disposal. Seek advice from the local authority regarding disposal.
<b>Fire</b>	<b>Call the Fire Service: Dial 111.</b> Keep non-involved persons away. When fighting fire wear full protective clothing and self-contained breathing apparatus.  Prevent fire extinguishing water from contaminating surface water or the ground water system. Collect contaminated fire extinguishing water separately. This must not be discharged into drains. Fire residues and contaminated fire extinguishing water must be disposed of in accordance with local regulations  <b>Small Fire:</b> Use dry chemical, CO2, water spray or regular foam. <b>Large Fire:</b> Use water spray, fog or regular foam. <b>DO NOT</b> scatter spilled material with high-pressure water streams. Move containers from fire area if you can do it without risk. If area is heavily exposed to fire and if conditions permit, let fire burn itself out since water may increase the area contaminated.

<b>If Swallowed</b>	For advice contact the National Poisons Centre 0800 POISON (0800 764 766) or a doctor. <b>DO NOT</b> induce vomiting unless directed to do so by a physician or poison control center. If victim is conscious: Rinse mouth with water.
<b>If in Eyes</b>	If easy to do, remove contact lens, if worn. Hold eye open and rinse slowly and gently with water for 15-20 minutes. If eye irritation persists, consult a specialist. Call the National Poisons Centre 0800 POISON (0800 764 766) or doctor for treatment advice.
<b>If on Skin</b>	Take off all contaminated clothing immediately. Rinse skin immediately with plenty of water for 15-20 minutes. Call a the National Poisons Centre 0800 POISON (0800 764 766) or a doctor for treatment advice.
<b>If Inhaled</b>	Remove person to fresh air. If signs/symptoms continue, call the National Poisons Centre 0800 POISON (0800 764 766) or a doctor immediately. Artificial respiration and/or oxygen may be necessary. Call a poison control center or doctor for treatment advice.

**STORAGE AND SEGREGATION SUMMARY**

**Storage:** Store in original container in a cool, dry, ventilated place away from direct heat or direct sunlight. Store away from foodstuffs, children and animals. Keep container sealed when not in use.

**Aggregate Storage Volume Thresholds:** When stored with substances of the same hazard the aggregate quantity must be considered. For full details refer to the current NZS8409 Management of Agrichemicals and the HSNO Regulations.
